

**Arizona Department of
Revenue Guidelines
ARS 43-1089**

***The credit is applied against the taxpayer's Arizona state income taxes.*

***Extra curricular activities are defined as... "School-sponsored educational and recreational activities that require enrolled students to pay a fee in order to participate."*

***Checks must be made payable to the school.*

***The credit is available for any personal income tax return.*

***It is not a requirement that the taxpayer have a child enrolled in the public school.*

***The credit is limited to \$200 per individual tax return or \$400 for couples filing a joint return.*

Frequently Asked Questions:

Can I still contribute to the school if I already paid more in taxes through payroll deduction than I owed and am now due a refund?

You will receive up to \$400 more in your refund if you have already overpaid and you donate the maximum amount.

What if I owe additional monies for state income tax?

You may deduct up to \$400 from your taxes owed to offset like contributions to any school in Parker Unified School District.

For example:

If a total of \$1,000 was deducted from your earnings during the year, and at tax time your AZ income tax liability was only \$600, the AZ Department of Revenue would owe you \$400 without a school tax credit.

Your refund check: \$400

If, however, you had contributed \$400 to a public school, the AZ Department of Revenue would refund you the \$400 PLUS another \$400 refund for the school tax credit.

Your refund check: \$800

If a total of \$1,000 was deducted during the year and your total AZ income tax liability was \$1,400, you would still owe \$400. You could deduct your \$400 school tax credit from your tax balance due.

Your taxes still owed: \$0

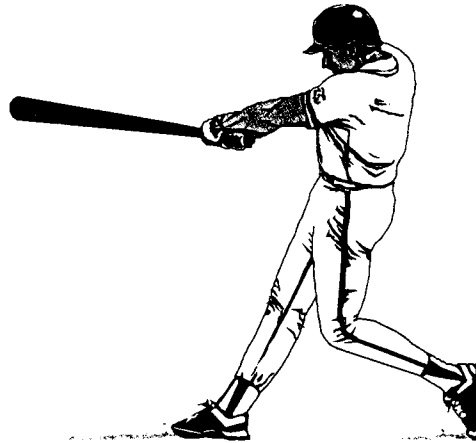

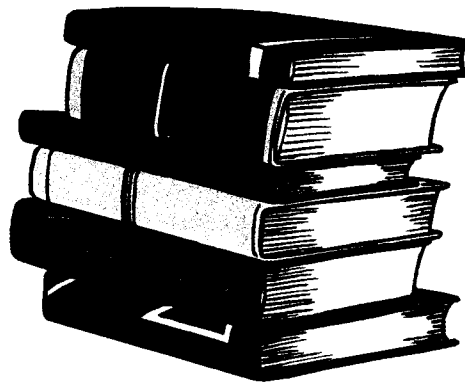
ABOUT THE PROGRAM...

The AZ Department of Revenue has issued guidelines that allow an individual income tax credit of up to \$200 for any fees contributed by an individual taxpayer to a public school for the support of extra curricular activities (ARS 43-1089). Couples filing jointly may contribute up to \$400. It is not a requirement that the taxpayer have a child enrolled in a public school.

Remember... your contribution must be dated by December 31st of the taxable year for which the credit is claimed
